**New Delhi, April 23:** Tata Motors (TML) on Saturday said it plans to raise ₹300 crore through issuance of non-convertible debentures (NCDs) to meet its expansion plan.

The fund-raising is a part of the company's plan to mop up ₹4,400 crore through issuance of NCDs in one or more tranches on a private placement basis. The company intends to raise the NCDs for a tenure ranging between two and 10 years. **PTI**
